#### 1 Who should read this document?

This document is directed to physicians, medical technicians and nursing staff, who are familiar with the EEG and the interpretation of it. It ensures them a safe use of the system.

## 2 Who can use UNEEG™ EpiSight Analyzer?

UNEEG™ EpiSight Analyzer is intended to be used by qualified physicians, qualified medical technicians and qualified nursing staff.

## 3 What can UNEEG™ EpiSight Analyzer be used for?

UNEEG™ EpiSight Analyzer aids the qualified user in the analysis and review of EEG data recorded with an electroencephalography device using subcutaneous electrodes. UNEEG EpiSight Analyzer offers a user interface for reviewing EEG recordings. The user interface is optimized to display a low number of electrodes. The EEG viewer can show results of algorithms for the analysis of EEG data. The analysis results are presented in a graphical user interfaces which shall aid the user in the examination of EEG recordings.

#### 3.1 EEG viewer

The EEG viewer is optimized to display EEG signals for a low number of electrodes. It includes frequency filtering of the data, the scaling of the data in x and y direction and the visualization in different montages. Automatic analysis of EEG data is started as soon EEG data has been imported into the the EEG Viewer. The analysis results are presented in the EEG viewer which shall aid the user in the examination of EEG recordings. The analysis includes the seizure detection, detection of rhythmic pattern, background frequency and aEEG.

#### 3.2 Seizure Detection

The UNEEG™ EpiSight Analyzer seizure detection allows the automatic detection of areas in EEG recordings that may correspond to electroencephalographical recognizable epileptic seizures and displays these markings for review.

#### 3.3 Detection of rhythmic pattern

UNEEG™ EpiSight Analyzer pattern detection automatically detects EEG-patterns defined in the Standardized Critical Care EEG Terminology of the American Clinical Neurophysiology Society (Hirsch, L.J., et al., 2013. American Clinical Neurophysiology Society's Standardized Critical Care EEG Terminology: 2012 version. J. Clin. Neurophysiol. 30, 1–27) and graphically presents the results to the user. Additionally, it detects and visualizes rhythmic patterns with frequencies of up to 12Hz. It serves as a support during the examination of EEG-recordings.

#### 3.4 Background frequency

The background frequency in UNEEG™ EpiSight Analyzer analyses the dominant background frequencies of the EEG. These are displayed for the four frequency ranges beta band, alpha band, theta band and delta band.

#### 3.5 aEEG

The aEEG in UNEEG™ EpiSight Analyzer presents the amplitude-integrated EEG according to "Zhang, D., Ding, H., 2013. Calculation of compact amplitude-integrated EEG tracing and upper and lower margins using raw EEG data. Health (N. Y.) 05, 885–891"

### 3.6 Spectrogram

The UNEEG™ EpiSight Analyzer spectrogram graphically provides the user with a spectrogram for all EEG channels within a defined time range.

### 4 Life Span

The life span of this version of UNEEG™ EpiSight Analyzer ends on Windows 10 64-bit operating systems on 2025-10-14 (October 14<sup>th</sup> 2025). As of this date, no more error corrections will be performed for UNEEG™ EpiSight Analyzer on the named operating system and this version of UNEEG™ EpiSight Analyzer may no longer be used.

# 5 For which patients can UNEEG™ EpiSight Analyzer be used?

UNEEG™ EpiSight Analyzer can be used on EEG data of adults over the age of 18 years. There are no restrictions on weight, health, gender, or nationality. The use in children is not recommended since specificity and sensitivity are not sufficiently defined due to the low amount of available EEG data from children during clinical validation.

#### 6 Are there restrictions of use?



UNEEG™ EpiSight Analyzer is CE-certified as a medical device. If your country requires any other approval for medical devices you must not use UNEEG™ EpiSight Analyzer.



The modules from UNEEG™ EpiSight Analyzer for the automatic analysis of EEG cannot replace the examination by the physician. As for any other automatic procedure, there can be inaccuracies during the analysis with UNEEG™ EpiSight Analyzer. The original EEG still needs to be used for the evaluation and the results of UNEEG™ EpiSight Analyzer need to be confirmed based on the unaltered raw EEG trace.



UNEEG™ EpiSight Analyzer does not provide any diagnosis or diagnostic recommendation, conclusion or prediction of the patient's state. It remains the responsibility of the physician to decide on the diagnosis or to induce treatment.



The use of the software cannot replace the real-time surveillance by medical staff particularly of the vital functions. The patient's safety remains the responsibility of the medical professional.

The maximum length for continuous EEG recording that can be reviewed and analyzed with the EEG viewer is 15 months. If a recording is longer than 15 months UNEEG™ EpiSight Analyzer will stop processing.

For UNEEG™ EpiSight Analyzer seizure detection, detection of rhythmic pattern, aEEG and background frequency the EEG of at least three subcutaneous electrodes must be available.



UNEEG™ EpiSight Analyzer seizure detection cannot be used as an alarm system, since there may be a delay of several minutes between the clinical onset of a seizure and the display of the detected pattern. Some EEG-events with epileptic seizures that have an electrographic correlate might be missed. For this reason UNEEG™ EpiSight Analyzer can only support but can not replace the qualified expert in the real-time monitoring.

Analyzer should not be used as an alarm system, since the visualization of patterns could be delayed by up to several minutes.

Some events, where patterns defined in the Standardized Critical Care EEG Terminology of the American Clinical Neurophysiology Society are visible in the EEG, might be missed. All measures of UNEEG™ EpiSight Analyzer must be evaluated in combination with the original raw EEG and must not be the only basis for a diagnosis, treatment or change of treatment.

## 7 How is UNEEG™ EpiSight Analyzer installed and launched?

UNEEG™ EpiSight Analyzer is delivered with an installation program that guides the user through the installation process and installs the software on the user's PC. The user needs administrator rights to install the software and to license it. The user should therefore contact the IT-department.



When configuring UNEEG™ EpiSight Analyzer with a remote analysis on a second PC it must be ensured that both PCs are running on the same system time. Difference of more than 1,5 minutes might interfere with the UNEEG™ EpiSight Analyzer system.



When using a database server it is the responsibility of the administrator of this database server to ensure that the database is properly secured against unauthorized usage. This includes strong passwords and enabling SSL encryption for accessing the database.

### 8 How is UNEEG™ EpiSight Analyzer started?

To review and analyze EEG data the program "EpiSight Analyzer.exe" must be started by the user. After the start of "EpiSight Analyzer.exe" the EEG viewer will open.

## 9 Is additional help for UNEEG™ EpiSight Analyzer available?

Additional help for UNEEG™ EpiSight Analyzer can be found in the electronic help system inside the software under the menu item "Help". Adobe Acrobat Reader is required for using the help. It can be downloaded directly from the Adobe webpage free of charge (https://get.adobe.com/reader).

# 10 Which EEG-data can UNEEG™ EpiSight Analyzer read?

UNEEG™ EpiSight Analyzer can only read data recorded with the UNEEG 24/7 EEG™ SubQ recorder.

# 11 Which EEG-systems support UNEEG™ EpiSight Analyzer?

UNEEG™ EpiSight Analyzer shall only be used with the UNEEG 24/7 EEG™ SubQ recorder.

### 12 Which service and maintenance measures are prescribed?

UNEEG™ EpiSight Analyzer does not require any particular service. The manufacturer has nevertheless the possibility to issue updates in irregular intervals. The manufacturer or the distributor will inform the user about these updates. It is recommended to promptly install these updates. Although the computer hardware is not part of UNEEG™ EpiSight Analyzer it is recommended to service the computer hardware running UNEEG™ EpiSight Analyzer in regular intervals. Particular attention should be given to ensure that sufficient free storage space is available for the operating system to run faultless. The user needs to ensure that the hardware of the computer system fulfills the minimum requirements that are listed in this document.



We strongly recommend that you back up the database used for UNEEG™ EpiSight Analyzer on a daily basis to prevent data loss. If the database is not available, all results are irretrievably lost.

### 13 Can UNEEG™ EpiSight Analyzer be combined with other medical products?

UNEEG™ EpiSight Analyzer is a stand-alone EEG analysis software. UNEEG™ EpiSight Analyzer can be used to analyse EEG data recorded with a UNEEG 24/7 EEG™ SubQ recorder and to download data from a UNEEG™ ProConnect system.

### 14 Which application environment is necessary?

The medical device is a supplement to an EEG recording device and can be used wherever EEG data are recorded and evaluated. This can be done within a hospital or a doctor's office. Also mobile use on a laptop outside a doctor's office or a hospital is possible. The medical device can be used wherever the proper use of the required computer hardware is ensured. UNEEG™ EpiSight Analyzer is not intended to be used outside closed rooms.

# 15 What are the UNEEG™ EpiSight Analyzer system components?

The system is made of the software UNEEG™ EpiSight Analyzer with the functions described above. UNEEG™ EpiSight Server is needed to connect to a UNEEG™ ProConnect system. The LicenseTool licenses UNEEG™ EpiSight Analyzer and is not required for later use. The installer installs and de-installs the system and is not required for later use.

## 16 How is UNEEG™ EpiSight Analyzer disposed?

UNEEG™ EpiSight Analyzer can be completely removed by the uninstall mechanisms that are provided by the operating system. Alternatively, UNEEG™ EpiSight Analyzer can be removed using the installer. This tool is a component of the UNEEG™ EpiSight Analyzer software.
